GUIDELINES ON SALE OF ROPA-VEHICLES IN LUZON YARDS AS OF JANUARY 16, 2020

A. BID PROCESS / GUIDELINES:

- 1. All newly foreclosed units offered for sale are subject to bidding.
- 2. Bids are considered non-transferable.
- 3. Acceptance of bids as follows:

San Pedro, Laguna - January 18 - 28, 2020 Urdaneta Pangasinan - January 18 - 24, 2020 Mexico & Lubao, Pampanga - January 18 - 24, 2020

- 4. Only sealed bids shall be accepted.
- 5. Bids shall be submitted at the yard/BGC Office. Bids received via e-mail /FAX will be disqualified.
- 6. Deadline of acceptance of sealed bids as follows:

San Pedro, Laguna - January 28, 2020 @5pm Urdaneta Pangasinan - January 24, 2020 @5pm Mexico & Lubao, Pampanga - January 24, 2020 @5pm

- 7. Opening of bids shall be on January 30, 2020.
- 8. Winning bidders shall be notified on January 31, 2020.
- 9. Winning bidder of multiple units must buy all the units won. Otherwise, all bids of the said bidder will be disqualified.
